Hi June,

I have put a bit of an overview of the KCC event for those who aren't too familiar with it. This is obviously our third year and it really has gone from strength to strength over our first two years. We simply aim this year to continue with the blueprint and template that has been established.

Something that has been raised a couple of times by people I have spoken to with our previous events is trying to connect our community's two Christmas events together on the same day. Previously we had our event later in the month so this never quite worked but this year we are looking at Sat 7th Dec as our event date. We are still waiting for RDC to confirm this availability however.

Logistically how we would we bring the events closer together have brought up two options our side and it would be good for your group to discuss to see what would be preferred or if there is another idea that may work.

The first is keeping your event at the same time and simply have two events on the same day but separate. The 2nd is having it a bit later in the day and ending the parade down at the domain as our event kicks off blending them together.

If the earlier option is decided to be better for you we have doubts whether we could accommodate all the floats coming down to the domain earlier as it could potentially be a hazardous site with lots of people turning up due to our stage and site setup is normally still in setup and soundchecks until 2-3pm.

I'm sure we can work out something that will work for both groups we are happy to look at options.

I can attend the next meeting you have or when you have time to discuss after talking about it first among yourselves.

# **King Country Christmas 2019**

#### Overview

King Country Christmas (KCC) was held for the second time on Saturday 15th December 2018 at the Taumarunui Domain Grandstand area from late afternoon through to evening. It was an immensely successful event attracting estimates at close to 2000 people which is double the number that attended our inaugural event in 2017. This is a fantastic turnout for a town of a population under 5,000. Social media came alive after the event with many people praising it or those who missed out wishing they had made it. The fireworks were especially another highlight with many commenting that it had even outdone the incredible display they had seen the previous year.

KCC 2019 aims to build on the obvious success of our two previous events by continuing to provide the community with an event that appeals to people of all ages, demographics, socio groups, but especially families as it will be an alcohol-free event with free entry.

The event will continue to celebrate local talent through the concert and help to give people the chance to remember the traditions and nostalgia of the Christmas season through all genres of singing, dance, drama as well as comedy, choir and carols by candlelight.

And of course the now famous fireworks display will return!
