#### 6. Chairperson Report

The Chairperson reported that she had met and liaised with the new owner of the camping ground, that she had been involved in exploring the possibility of co-ordinating a possible new art event in Taumarunui and had been keeping herself apprised of progress with the establishment of the pet food factory. She noted the possibility of the pet food factory being the locus of a possible Business after 5 event in future.

#### 7. Revitalisation Taskforce Update

Karen Ngatai, the Chairperson of the Taumarunui Revitalisation Taskforce reported:

- That she had arranged for a grant of \$800 to enable Enrich to undertake a mural on the wall of a building adjacent to Harland Graphics which was opposite PGG Wrightsons,
- That two more birds were in the process of being completed for Manson's Garden
- That the painted panels were shortly to be erected on the flyover bridge,
- That three more replacement trees were to be planted in the Rhododendron row alongside State Highway 4,
- That the dispute over the mowing of the vegetation around the row of Rhododendrons was scheduled for a hearing by the small claims tribunal on 7 September.

# 8. Briefing on Matariki Festival

Karen Ngatai reported that the festival had been very successful enjoying strong participation from the public and financial support and support in kind from a wide variety of organisations and individuals.

It was mooted that future festivals could include a "Light Up Your Town" initiative encouraging people to light up their homes including the possibility of holding a competition.

It was reported that there were impending changes in the organisers of the Te Huapae o Matariki Winter Festival and it was accordingly:
